- a) Terri Hughes, with Atmos briefly discussed the importance of dialing 811 and gave her cards to anyone that would like to contact her regarding issues or needing more information.
- b) Susan Shaw, Tax Assessor stated with Angie Alvarado retiring she would be promoting Tarran Deleon as chief deputy once Angie retires. She stated that Tarran Deleon is a great asset with 12 years tax experience
- 2. Department Updates:

EMS Service - Carly French

Carly French, EMS Director presented updates and statistics regarding ambulance and a new van purchases, staff, cost of services, mileage, transfers and income brought in. She stated that revenue has increased due in part to these changes and updates. (see attached)

Commissioner Houston made a motion to approve the contract with Garza County for inmate housing at \$62 daily as presented by Ronny Pipkin, Sheriff. Commissioner Murphree seconded the motion. Motion carried unanimously. (see attached)

Commissioner Elder made a motion to approve a Request for Qualification from JSA to be the architect firm available for the county on certain projects. Commissioner Murphree seconded the motion. Motion carried unanimously. (see attached)

Commissioner Rosson made a motion to approve a BuyBoard purchase of a manlift from Associated Supply Company Inc. (ASCO) Equipment for county wide use at a cost of \$93,138.00 to be paid out of ARPA funds. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)

Judge Therwhanger- She expressed thank you to the precincts involved in the renovations at the Parks and Golf Course. She stated there needed to be a designated cooking area at the Park building as not under the awning at the building, the concrete slab is complete with minor cracks and they are being repaired, the old house has been torn down, leaks fixed and the golf cart paths completed.

Commissioner Rosson- He stated Romero Guerro, Seagraves Police Department Chief had contacted him regarding the part of the building not in use that the tax and JP's office currently are in. He stated this would be something the court would be willing to rent to him for the police department, however, more research and discussions are needed.

Commissioner Elder-He stated he will be using the insurance money to drill water on CR 218 at the caliche pit & placing a tank there and Higginbotham for the fire department use and upgrading his building.

Commissioner Murphree- He stated the power lines have been buried at the walking park and cement will be poured today and will most likely complete the lighting project next week. He stated the old sign at the golf course has been taken down and where there once was an arch at the entrance and it has old slabs that will evidentially be taken down
