Call to Order - Judge Cindy Therwhanger Invocation

- 2. To consider, discuss, and take any necessary action on routine administrative items:

 - Scott Nichols, Golf Course Superintendent, stated the irrigation system has been installed, Sod should be in and ready to be laid on the 25th and would need 4 installers and help from each precinct. He stated he would purchase a starter fertilizer at an approximate cost of \$1,200-\$1,400. He stated the progress with all the projects is good.
- 4. Meet with Chamber of Commerce Director Shawntay Pettyjohn to report on Freedom Fest.

Shawntay Pettyjohn, Chamber of Commerce Director stated the Freedom Fest was a success and stated there needs to be better communication with 1st responders and vendors next year and the need for a 2nd sound system. She stated the delay in the fireworks and the veterans ceremony and the band performance not happening was due to the rain. She thanked the commissioners for all their support.

 Michael Lord, Treasurer stated the agreement between BCBS and Covenant was still in place with no changes and the Wellness bus would be here September 3rd and 4th.

 - Joe Vest, Sheriff did a presentation regarding the need for adding an E-Ticket system for the Sheriff's Office, stating this would cut down on process time and cost. He presented 3 different companies that offer this. Sheriff Vest stated he thought Peace Maker would suit the needs at a cost of \$11,000 with a 4 year subscription and at that time they would replace the equipment. This item was table until Sheriff Vest gathers more information and presents to the court for approval.
