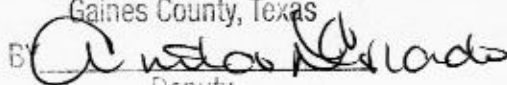

4. **Terms of Sale.** The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the Deed of Trust permitting the Mortgagee thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the Deed of Trust at the time of sale. Pursuant to §51.009 of the Texas Property Code, the property will be sold in "AS IS, WHERE IS" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the Deed of Trust.

5. **Notice Regarding Federal Reporting Requirements.** Please be advised that the highest bidder ("purchaser") at this trustee's sale may be required to provide information, documentation and/or certification as mandated by applicable federal law, and entity and trust purchasers should be prepared to provide beneficial ownership information as may be required by federal reporting requirements effective for transfers of residential real property to covered transferees on or after 3/1/2026. 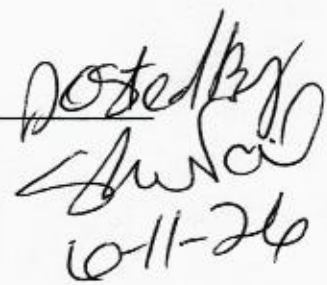

**EXHIBIT "A"
LEGAL DESCRIPTION**

The West part of Lot 49, Block 4, Belcher Addition No. 2 to the City of Seagraves, Gaines County, Texas, and being more fully described by metes and bounds as follows, to-wit:

BEGINNING at a 3/8" iron rod at the Southwest corner of said Lot 49 for the Southwest corner of this tract; THENCE North, along the West line of said Lot 49, a distance of 145.01 feet to a 3/8" iron rod at the Northwest corner of said Lot 49 for the Northwest corner of this tract; THENCE East along the North line of said Lot 49, a distance of 49.93 feet to a 3/8" iron rod for a corner of said Lot 49 and a corner of this tract;

THENCE South, 59° 16' East, along the Northeast line of said Lot 49, a distance of 70.03 feet to a 1/2" iron rod for the Northeast corner of this tract, from which the Northeast corner of said Lot 49 bears South 59° 16' East 9.22 feet;

THENCE South 21°04' West 134.31 feet to a 1/2" iron pipe in the South line of said Lot 49 for the Southeast corner of this tract, from which the Southeast corner of said Lot 49 bears South 69° 36' 30" East 9.09 feet;

THENCE in a Northwesterly direction, along the arc of a circular curve to the left (Radius=362.68 feet), 63.92 feet to the PLACE OF BEGINNING; SAVE AND EXCEPT all oil, gas and other minerals.
