WHEREAS, by *Deed of Trust*, (herein "Deed of Trust") dated *June 2, 2009*, *Marie Rascon*, conveyed to *Joe K. McGill*, Trustee, for the benefit of *Henry Elias*, certain real property situated in *Gaines County, Texas*, to wit:
