

THENCE S.87°45'04"E., along the North line of said Tract 23, a distance of 225.00 feet to a ½" iron rod with cap marked "NEWTON SURVEYING" set at the Northwest corner of the E/2 of said Tract 23 for the Northeast corner of this tract (bearings compared to the Texas Coordinate System of 1983, North Central Zone, distances are true at an averaged surface elevation);

THENCE S.02°27'56"W. 190.00 feet to a ½" iron rod with cap marked "NEWTON SURVEYING" set at the Southwest corner of said E/2 of Tract 23 for the Southeast corner of this tract;

THENCE N.87°45'04"W., along the South line of said Tract 23, a distance of 132.40 feet to a ½" iron pipe found in the South line of said Tract 23 for the Southeast corner of a 0.17 acre tract and for the most Southerly Southwest corner of this tract;

THENCE N.02°27'56"E. 82.00 feet to a ½" iron rod with cap marked "NEWTON SURVEYING" set for the Northeast corner of said 0.17 acre tract and for a corner of this tract;

THENCE N.87°45'04"W. 92.60 feet to a ½" iron rod with cap marked "NEWTON SURVEYING" set for the Northwest corner of said 0.17 acre tract and for the most Westerly Southwest corner of this tract;
