ALTERNATIVES TO PAYMENT OF FINES AND COSTS

A defendant who is convicted of a criminal offense punishable by fine only is entitled to alternative methods of satisfying the judgment against them if they are unable to pay the fine or costs, in whole or in part.

Those alternative methods include:

- 1) A payment plan, allowing the defendant to make payments toward the fine and costs in designated intervals. Note that if any amount is paid more than 30 days after the judgment assessing the fine or costs then a \$15 time payment fee must be assessed.
- 2) Disposition of the amount assessed by performing community service. There are many options that meet the requirements of the law for community service, see Art. 45.049 of the Code of Criminal Procedure for full details. A defendant is entitled to a minimum of \$100 credit for every 8 hours of community service performed.
- 3) If performing community service imposes an undue hardship, a defendant who is indigent or who lacks sufficient resources to pay may be entitled to a waiver of the fine and costs, in whole or in part.

DRIVER SAFETY COURSE UNDER T.C. 45.0511

You may be able to request this charge be dismissed by taking a Driver Safety course. However, YOU WILL LOSE THAT RIGHT IF YOU DO NOT PROVIDE WRITTEN NOTICE TO THE COURT ON OR BEFORE YOUR APPEARANCE DATE.

Under T.C. 45.0511 (P)(2) Commercial Driver's License holders and (P)(3)those persons charged with Speeding in a Construction Zone with workers present or anyone speeding 25 mph over the posted speed limit are not eligible for a Driver Safety Course.

You must send the following BEFORE the appearance date on your citation. FAILURE TO FURNISH ITEMS REQUESTED BY THE COURT FOR DSC WILL RESULT IN DENIAL OF YOUR REQUEST.

- Copy of Valid Texas Driver's License.
- · Copy of Liability Insurance
- Remit a MONEY ORDER or CASHIER'S CHECK in the amount of \$144.00.
- Obtain a certified copy of your driving record obtained from TEXAS.GOV
- DSC Request form (located below) filled out in full and with a return mailing address. We must have mailing address in order to send approval.

You will receive approval/denial from the Court after receiving all of the above requirements. Please allow a couple of weeks to receive approval or denial.
