Court observed a moment of silence followed by the opening invocation given by Commissioner Yocom. Judge Keyes led the pledge to flags. The meeting was called to order at 10:00 a.m.

- 1. Discuss routine administrative items: take action needed
 - a. Last month's minutes
 - b. Payroll
 - c. Budget amendments and fund transfers
 - d. Accounts payable
 - e. Auditor's report
 - f. Officer's report

Commissioner Belt made a motion to accept and approve the routine administrative items as presented. The motion was seconded by Commissioner Tharp. The motion carried unanimously. (see attached)

- 2. <u>Meet with Joe Grimes, PE, Grimes & Associates, to discuss and take action as appropriate on the following items:</u>
 - a. <u>Discuss the formal application to TCEQ and plan to dispose of waste RO water at the County Park</u>
 - Joe Grimes reviewed the Application for Industrial Reuse of Waste Water and plans to dispose of waste RO water. Commissioner Yocom made a motion to authorize Joe Grimes to move forward on the application. The motion was seconded by Commissioner Belt. The motion carried unanimously.
 - b. <u>Discuss a request for a survey of the County Park and Golf Course to support the plan to get RO water distributed to the new Community Center, RV sites, lavatories and Park Superintendent's house</u>
 - Joe Grimes requested pricing from three different surveyors for RO water distribution. The lowest price was from Newton & Associates at \$5,000.00 for the Base Survey and \$2,500.00 for the Expanded Survey, for a total of \$7,500.00. Commissioner Belt made a motion to authorize Newton & Associates to do the survey. The motion was seconded by Commissioner Yocom. The motion carried unanimously. (see attached)
- 3. <u>Discuss a hanger modification at the airport for Jevon Cheuvront; take action as appropriate</u>
 - Following a lengthy discussion, Commissioner Tharp made a motion to table this item for further study. The motion was seconded by Commissioner Belt. The motion carried unanimously.
- 4. Meet with Sheriff Ronny Pipkin concerning jail inspection; take action as appropriate Sheriff Pipkin read a letter from Brandon Wood, Executive Director of the Texas Commission on Jail Standards, acknowledging a Certificate of Compliance with Texas Minimum Jail Standards. Sheriff Pipkin expressed his appreciation to the Court for their support. (see attached)
- 5. Meet with Sheriff Ronny Pipkin to discuss guardian system for the jail; take action as appropriate

Sheriff Pipkin stated the inspector reviewed the jail inmate checks done once an hour and manually logged. The inspector stated the Commission will eventually go to an automated jail check system and he highly recommended the County consider it. Pipkin reviewed the Guardian System at a set up price of \$18,000.00 with an annual fee of \$2,800.00 for future study and consideration. (see attached)

- 6. Consider a proposal to allow Southwest Contractors to demolish the Rehab building; take action as appropriate
 - Judge Keyes presented a proposal from Southwest Contractors in the amount of \$24,098.00 to do demolition on the rehab building. Pricing includes hauling off to the City landfill, moving electrical meters and the HVAC unit. Commissioner Yocom made a motion to approve Southwest Contractors to demolish the building. The motion was seconded by Commissioner Belt. The motion carried unanimously. (see attached)
- 7. Consider accepting a new road in Precinct 1 road system; take action as appropriate Commissioner Yocom requested acceptance of a roadway in a subdivision (Rempel Subdivision) approved prior to the current subdivision rules. This is a 3020 ft. caliche road at 401K and 400N. Commissioner Yocom made a motion to approve a new road in Precinct 1 road system. The motion was seconded by Commissioner Belt. The motion carried unanimously. (see attached)
- 8. Consider accepting donations for the ball parks; take action as appropriate Commissioner Belt stated Native Energy has offered their labor to change the bulbs and tighten light fixtures at the Cal Ripkin and Walker Fields ball parks. Commissioner Belt made a motion to accept the donation from Native Energy. The motion was seconded by Commissioner Yocom. The motion carried unanimously.
- 9. Consider accepting resignation; take action as appropriate Judge Keyes stated he had received a resignation from Roy Barnes, Museum Director, effective May 6. Judge Keyes has begun the process of looking for a replacement. Commissioner Tharp made a motion to accept with regrets, the resignation of Mr. Barnes. The motion was seconded by Commissioner Belt. The motion carried unanimously.

This software will meet Texas Stars Program requirements and provide full transparency and detail reporting not available with the current budget software. Meet with Joe Nagy concerning an asset forfeiture audit; take action as appropriate Rick Dollahan, Auditor, requested Court approval to complete and sign the annual FY 2015 Chapter 59 Asset Forfeiture Report for the County Attorney's Office. Dollahan stated the County Attorney does not seize assets and there are no monies available. Commissioner Tharp made a motion to authorize the County Auditor to conduct audit and sign the report.
