Court observed a moment of silence followed by the opening invocation given by 106th District Attorney Philip Mack Furlow. Officer Protem Belt led the pledge to the flags. Judge Keyes was absent due to a death in the family. The meeting was called to order at 10:00 a.m.

- 1. Discuss routine administrative items: take action needed;
 - a. Last month's minutes
 - b. Payroll
 - c. Budget amendments and fund transfers
 - d. Accounts payable

 - g. Surplus/salvage

Commissioner Houston made a motion to accept and approve the routine administrative items as presented. Second by Commissioner Murphree. Carried unanimously (See attached)

2. Consider approving a resolution supporting the grant application for the Dawson and Gaines Victims Assistance Program; take action as appropriate

106th District Attorney Philip Mack Furlow requested approval of a Resolution regarding the Submission of a Grant for the Dawson and Gaines County Victims Assistance Program. Commissioner Murphree made a motion approving the resolution as presented. Commissioner Houston seconded the motion. Carried unanimously. (See Attached)

3. Consider increasing the part-time budget line in maintenance to allow maintenance to hire temporary employees to perform demolition work in old jail; take action as appropriate

Auditor Dollahan suggested increasing part time budget line in maintenance for demolition work in the old jail, recommending moving funds from undesignated reserves. Motion approving by Commissioner Houston, second by Commissioner Rosson. Carried unanimously.

4. Consider funding work planned at the park and museum in Seagraves; take action as appropriate

Commissioner Rosson made a motion to fund work at the Seagraves Park and Museum, requesting \$10,000.00 from capital project fund. Second by Commissioner Murphree. Carried unanimously.

5. <u>Consider proposals that have been submitted for fencing at the Seagraves Cemetery;</u> take action as appropriate

One proposal was received from FW&C in the amount of \$84,490.00. Commissioner Rosson stated he will present this proposal to MS Doss Foundation requesting a grant.

Commissioner Rosson made a motion to accept the proposal as presented. Seconded by Commissioner Houston. Carried unanimously. (See attached)

6. Consider transferring vehicle to DA's office for \$1000.00; take action as appropriate

Commissioner Rosson made a motion to transfer a 2011 Dodge Charger to the District Attorney's office, to be used by the Investigator, for a total of \$1,000.00. Second by Commissioner Houston. Carried unanimously.

106th District Attorney addressed the Court giving a 100 day report of activities and statistics for the DA's office.

7. Consider adopting a resolution concerning policy and procedure to apply for speed control devices on county roads; take action as appropriate

Commissioner Houston presented a Resolution regarding speed control devices on county roads. Houston made a motion approving the resolution, seconded by Commissioner Rosson. Carried unanimously. (See attached)

Auditor Dollahan presented a resignation letter from Pct. 1 Constable Chad Hallum, as he has accepted a fulltime position as Chief Deputy for Gaines County Sheriff's Office. Commissioner Murphree made a motion to accept Hallum's resignation with the stipulation that he forego the Constable salary. Commissioner Rosson seconded the motion. Carried unanimously. 11. Consider approving surplus for Prect 4; take action as appropriate

Commissioner Houston made a motion to declare CAT 950F FE Loader Unit # 4054 as surplus for trade-in. Commissioner Rosson seconded the motion. Carried unanimously, (See attached)
