Court observed a moment of silence followed by the opening invocation given by Judge Keyes, who then led the pledge to the flags. The meeting was called to order at 10:00 a.m.

- 1. Discuss routine administrative items: take action needed;

Commissioner Belt made a motion to accept and approve the routine administrative items as presented. Commissioner Houston seconded the motion. Carried unanimously. (See attached)

2. <u>Consider a proposal to preserve and frame original drawings from 1919 courthouse</u> plans; take action as appropriate

Judge Keyes presented a proposal to preserve and frame original 1919 courthouse drawings, from Kofile Technologies in the amount of \$3,060.00. Commissioner Houston made a motion approving the project, with a second by Commissioner Rosson. Motion carried unanimously. (See attached)

3. <u>Consider going out with a RFQ for Engineering Support for the repair and refurbishment</u> of buildings damaged by hail; take action as appropriate

Judge Keyes presented a Request for Qualifications for court approval. Commissioner Belt made a motion to go out for RFQ, to be opened July 10th. Commissioner Rosson seconded the motion. Carried unanimously. (See attached)

Judge Keyes presented a Zoning Board Notice to change Zoning designation from Agriculture Estates to Local Retail for 93 acre tract in South part of E/2 Section 190, North side of Section 191, West side of Section 161, and Northwest corner Section 160, Blk G WT Ry. Commissioner Houston made a motion approving the Zoning Designation change. Commissioner Belt seconded the motion. Carried unanimously. (See attached)

5. <u>Consider approving an employment contract between Sheriff Pipkin and one of his</u> <u>employees to pay for attendance at the Permian Basin Law Enforcement Academy; take</u> <u>action as appropriate</u>

Sheriff Pipkin presented an employment agreement between the Sheriff's Office and Blain Stanfield, to pay for attendance to the Academy. Commissioner Belt made a motion approving the agreement, with a second by Commissioner Murphree. Motion carried unanimously. (See attached) 6. <u>Consider declaring 5/8" white rock as surplus for Precinct 3, and consider going out for bids to sell it locally; take action as appropriate</u>

Commissioner Murphree made a motion declaring 1700 tons of rock as surplus and to go out for bids to sell locally, opening bids July 10th. Commissioner Houston seconded the motion. Carried unanimously. (See attached)

Commissioner Rosson made a motion to purchase a 2017 Caterpillar Smooth Drum Roller, through Buy Board with two trade in's, for a total cost of \$57,950.00. Commissioner Murphree seconded the motion. Carried unanimously. (See attached)

Commissioner Rosson made a motion declaring Unit # 1130 and Unit # 1160 as surplus to trade in on the previously approved purchase, second by Commissioner Belt. Carried unanimously. (See attached)

9. Consider approving buy board purchase for S.O.; take action as appropriate

Sheriff Pipkin requested approval of the purchase of a 2017 Chevrolet C15 4WD in the amount of \$35,096.00, to be paid from reserves. This will replace Unit S91. Commissioner Belt made a motion approving the purchase, with a second by Commissioner Houston. Motion carried unanimously. (See attached)

10. <u>Consider approving a request for partial payment for supplies needed for fence in</u> <u>Seagraves; take action as appropriate</u>

Judge Keyes stated the vendor installing the fence has requested a partial payment to cover the materials purchased for the fence. Commissioner Rosson made a motion approving partial payment to FWC Oilfield Services, and authorizing the Auditor to pay this invoice today. Commissioner Belt made a second to the motion. Carried unanimously. (See attached)
